Any tender, found as not fulfilling the eligibility criteria will be rejected at this stage and such offers will not be considered for further processing. The price bid of only those tenderers who have been qualified during the scrutiny and technical evaluation will be opened separately on a specified date (with due intimation to the qualified bidders) and further processed, as per tender procedure/ stipulations.

Any breach of this condition by the contractor would render him liable for rejection of tender or cancellation of contract.

Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.
