1	Whether beyond 18 months, prices are to be revised?	The price quoted by the Vendors will be firm and fixed for 3 years.
2	What is the maximum number of units for outstation work?	Maximum up to 2500 units.
3	Is there some predatory pricing?	<p>Quotes with abnormally low price shall be treated as per the below mentioned extant rule:</p> <p><i>“An Abnormally Low Bid (ALB) is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. The procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, allocation of risks and responsibilities, and any other requirements of the tender document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/ Proposal and evaluate the next higher bidder (and so on), at his/ their own quoted rate (if considered reasonable, and not by the counter-offering rate of ALB), for the award of contract “.</i></p>
