1. INTRODUCTION

Ammonium Perchlorate Experimental Plant (APEP), Vikram Sarabhai Space Center (VSSC), ISRO is located at Aluva, Kerala. APEP manufactures Ammonium Perchlorate (AP) for ISRO's rocket programs. Sodium chlorate is one of the major and critical raw materials for manufacture of AP. Its purity and quality has a high impact on the properties of AP.

APEP (Purchaser) requires Sodium Chlorate of pure grade as per IS 5301-1987 (Reaffirmed 2022). Approximate annual requirement of sodium chlorate at VSSC is in the range 1200 MT to 2400 MT. It shall be delivered in staggered lots, based on monthly needs.

2. OBJECTIVE OF EOL

This Expression of Interest (EOI) is aimed at identifying competent Indian manufacturers of sodium chlorate and qualifying them for supply to ISRO at the rate of 1200-2400 MT per annum or part, as required by the Department. The actual quantity may vary depending on programmatic requirements. ISRO may simultaneously procure sodium chlorate from other sources also, at the whole discretionary power of the Department.

3. QUALIFICATION PROGRAM

- a. Initially, the vendors will have to supply sodium chlorate samples (1 kg from a single batch) free of cost for laboratory level evaluation. The samples will be checked by the Purchaser for compliance with IS 5301-1987. Vendors who successfully qualify in 1 kg sample evaluation and meet all criteria as mentioned in this EOI shall be shortlisted for further assessment.
- b. A Technical Evaluation Committee (TEC) from the Purchaser shall visit the manufacturing facility of the vendors who have qualified the sample level evaluation process, to assess the eligibility criteria and for further recommendations for including as a vendor for bidding.
- c. A Limited Tender shall be floated among the vendors recommended by TEC, for the supply of 30 MT sodium chlorate prepared from three different production batches (10MT/ batch). Against the LT, the lowest priced bid meeting all the technical and commercial conditions as per the EOI will be considered for supply of 30 MT.

In order to have additional vendors, the department has the freedom to procure 30 MT sodium chlorate from all the parties shortlisted by TEC, who are willing to supply at the same rate as L1 bidder, for further qualification trials at VSSC.

The 30 MT sodium chlorate procured, will be evaluated by the Purchaser, at various levels in the following sequence:

- 1. At product level: All parameters listed in IS 5301-1987, for compliance
- 2. **At Ammonium Perchlorate level:** Ammonium Perchlorate (AP) will be produced using a part of 30 MT sodium chlorate. AP thus produced will be tested by the Purchaser at their labs for chemical, physical and thermal properties and it shall meet the specifications stipulated by the Purchaser.
- 3. At Propellant level: If the quality of AP produced complies with the specifications

stipulated by the Purchaser, further AP will be used for propellant level qualification to evaluate the properties of propellant in different formulations, by the Purchaser.

Vendor/ vendors shall be notified, if their product successfully completes the qualification program.

The bulk procurement (1200 – 2400 MT/year) of sodium chlorate will start only after successful qualification of vendor, based on the results of propellant trials conducted by the Purchaser, with the ammonium perchlorate produced using the supplied 30 MT sodium chlorate. For this bulk procurement, separate tender will be floated on LT basis including all qualified vendors (new and existing) of sodium chlorate.

4. SPECIFICATIONS OF SODIUM CHLORATE

Pure Grade Sodium Chlorate as per IS 5301-1987 conforming to the following:

5. REVIEW CRITERIA FOR EOI

Interested vendors shall submit the EOI within 30 days of this advertisement. The EOI shall contain the following details:

- a. Conformance to IS specifications for pure grade sodium chlorate to be supplied as per the specifications mentioned in SI: No.4 The supply lot should have been produced not earlier than 18 months from the date of supply. Test certificates, with traceability to the date of production and analysis results as per SI. No: 4 shall be furnished along with the supply of 1 kg free sample and 30 MT material.
- b. The supplier should be an established reputed chemical manufacturer, who has his own process plant for the production of sodium chlorate, with a production capacity of 20 MT/day or more.
- c. Manufacturing plant shall be located within India and exact location of the manufacturing facility shall be shared with the Purchaser
- d. Process description and process flow diagram of sodium chlorate manufacture.
- e. Once the product is qualified, the prescribed process steps as given in the tender document are to be strictly adhered and any change should be done only with the approval from the Department.
- f. Annual production statement of sodium chlorate for the last three years to be provided as documentary evidence.
- g. Present major customers of sodium chlorate, with quantity of annual supply and the contact details of customers shall be indicated.
- h. Annual turnover for the company for the past 3 years should be at least Rs.700

Lakhs per annum. The income tax return for the past 3 years to be provided as documentary evidence.

The details requested above shall be typed on company letter head and to be submitted along with the EOI. The EOI shall also be accompanied with 1 kg free sample of sodium chlorate manufactured from the normal production batch, along with the test certificate. It shall reach the Purchaser within 30 days from date of tender. The sample shall be sent to General Manager, APEP/ ISRO, Erumathala, P.O., Aluva, Ernakulum (Dist.), Kerala. PIN 683112. These samples shall be tested by APEP to confirm that it meets the product specifications mentioned in SI: No: 4.

Parties those do not meet the above criteria shall be rejected and excluded from the subsequent LT bidding process for procurement of 30 MT for qualification trials.

Party shall not mention price of Sodium Chlorate while submitting the EOI.

Only shortlisted suppliers will be considered for further supply of 30 MT Sodium chlorate for carrying out qualification trails as mentioned in SI No 3 of this EOI

6. OTHER TERMS AND CONDITIONS

6.1. Quality Control

- a. The party shall have stringent control on the quality of raw material used for the manufacture of the product Sodium Chlorate pure grade. The raw material test certificate along with its source shall be submitted to Purchaser corresponding to 1 kg sample and each batch of Sodium Chlorate, in connection with supply of 30 MT.
- b. ISRO shall have the rights for periodic inspection/auditing of the plant to verify the manufacturing steps/process. Party shall facilitate the visit in a notice as short as 24 h.
- c. The party shall have a well documented procedure for acceptance of raw material for the manufacture of Sodium Chlorate pure grade. The copy of the same has to be submitted to Purchaser along with submitting the proposal. Traceability of raw material used for manufacturing each batch of Sodium Chlorate shall be available.
- d. Only demineralized water shall be used in the processing steps for the manufacture of Sodium Chlorate.
- e. The sources for raw material mentioned in the tender shall only be used for the manufacture of Sodium Chlorate pure grade and the details of the sources shall be submitted to the Purchaser along with EOI.
- f. Party shall certify that the raw materials used for manufacturing 1 kg sample, qualification and the bulk supply lots (as per sl no. 3) shall be from the same source to ensure consistency in purity. Any change in source of raw materials for the supply of Sodium Chlorate to the Purchaser shall be only with the clearance of Purchaser.
- g. Company's quality management program and details of ISO certification if available shall also be given in the offer.
- h. The full address and contact details of the vendor with manufacturing plant address.

6.2. Sample submission

- a. Once the samples are submitted to the Purchaser for evaluation, under no circumstances changing/ replacing of samples shall be allowed.
- b. The authority to accept/reject samples based on acceptance criteria rests fully with the

- Purchaser and party will not be consulted.
- c. Once a sample is rejected, no further queries shall be entertained.
- d. No claim shall be entertained to collect back test samples, test certificates, reports, etc. Entire evaluation program shall be carried out by the Purchaser at their own facilities. At no point of time, any kind of intervention in the qualification program shall be entertained.
- e. Samples for qualification are to be delivered at APEP/ ISRO, Aluva by respective bidders.

7. GENERAL TERMS AND CONDITIONS

- a. This EOI is for shortlisting the probable vendors for Sodium Chlorate to ISRO only and in no way an agreement for its procurement in future.
- b. The vendor shall identify and inform a suitable technical person, who is thorough about the manufacturing process, (Engineer/ Manager) as focal point for further interactions
- c. Vendor shall be willing to enter into a long term/ short term agreement with ISRO for bulk supply.
- d. ISRO shall have the full authority to reject a vendor at any stage during or after the qualification program. Qualification of the sample does not guarantee that the vendor will be shortlisted as a probable vendor.
- e. ISRO shall have the right to short close the EOI and process of awarding contract without giving any details to the EOI respondents.
- f. ISRO has the right to split the PO and award contract to more than one vendors.
