TERMS & CONDITIONS

PART-I → TERMS & CONDITIONS FOR TECHNO-COMMERCIAL BID

1.0 Scope of Rate Contract

Scope of Rate Contract is to procure quality pharmaceutical products from reputed Manufacturers / Authorized Dealers.

2.0 Period of Rate Contract

VSSC proposes to enter into a Rate Contract for the supply of quality pharmaceutical products initially for a period of **ONE YEAR** from the date of issue of the Rate contract. This can be extended for a further period of **one year** on mutual consent.

3.0 Quality of Medicines

- 3.1 The Manufacturer / Authorized Dealer must submit valid WHO GMP Certificate/Equivalent to WHO GMP Certificates like EU- GMP or US FDA GMP for the products quoted.
- 3.2 The pharmaceutical company/authorized dealer shall certify that the medicines/drugs quoted for supply are as per the formulation specified/approved under the Drug Control Act and Food & Drug Control Administration Regulations or any similar Regulations. Self-declaration form to be signed by the authorized dealer or manufacturer to be provided in **Annexure-B.** The pharmaceutical company/authorized dealer shall be held responsible for consequences, if any, of supplying spurious, adulterated or sub-standard medicines/drugs not conforming to extant Act/Regulations.
- 3.3 Tenderer shall be either a manufacturer or authorized dealer or loan licensee or a direct importer (having valid import license issued by the Drug Controlling Authority of India).

 a) In case of manufacturer or authorized dealer or Loan licensee, there should be a valid manufacturing license issued by the drug controlling authority. b) In case of direct importer, there should be a valid import license issued by Drugs Controller General of India, New Delhi and the manufacturer should authorize the importer to deal business in India
- 3.4 Tenderer / manufacturing unit which has been blacklisted / debarred for any item either by the Tender inviting authority or by any state Govt. or central Govt. Organisation cannot participate in the Tender for that item during the period of blacklisting / debarment.
- 3.5 Valid, up-to-date Manufacturing License (including loan licenses, if any) with drug endorsement (i.e. the list of approved items /renewal of the license and it should be a single list) of the items quoted / copy of import license if items quoted are imported shall be submitted along with the offer. If the validity of license has expired on the date of submission of tender, then letter from the licensing authority is to be attached along with the tender submitted mentioning that the tenderer has applied for renewal as per D&C Act.

3.6 On receipt of supply orders, the pharmaceutical company/authorized dealer shall furnish a copy of the analytical report for each batch of medicines/drugs based on the formulation submitted by the pharmaceutical company and approved by the Drug Control Authority/Food & Drug Control Administration (FDCA), failing which the medicines/drugs supply shall be rejected. VSSC will be free to get the analytical test done by any of the FDCA approved laboratory.

4.0 Replacement with latest batches for medicines nearing expiry date / Return of unused medicines against credit note

- 4.1 The medicines/drugs supplied against each requisition should be from the latest batch/batches manufactured during the validity of the WHO GMP certificate or Equivalent to WHO GMP Certificates like EU- GMP, US FDA GMP. If the full quantity of medicines/drugs supplied could not be dispensed within the expiry date, the supplier shall replace the same from the latest batch/es.
- 4.2 The Supplier shall also take back any unused medicines and provide credit note for the same for adjusting the amount in the future payments.

5.0 Mode of Operation of this R/C

- 5.1 Supply Orders will be placed periodically against the finalized R/C. Chief Medical Officer, VSSC (CMO) is the authorized official to issue Supply Orders.
- 5.2 Supplies shall be made directly by the Manufacturer or through Authorized Dealer/Distributor only. Appropriate details in this respect shall be provided in **Annexure-C**. Valid authorization certificate from the Manufacturer shall be submitted wherever applicable.

6.0 Percentage of local content:

- 6.1 Non Local Suppliers shall also be eligible to bid along with Class I and Class II local suppliers as per the provisions of Make in India (MII) Policy issued by the Government of India. Class I local supplier is eligible for purchase preference as Govt. of India Public Procurement.
- 6.2 Confirm the percentage of local content in the item. Self-Declaration in this regard shall be submitted in the prescribed format as per Annexure-D.

7.0 Delivery Period of Medicines

- 7.1 Arrangement shall be made to supply quality medicines within the mutually agreed delivery period from the date of issuance of a Supply Order by CMO, VSSC.
- 7.2 **Delivery Period**: Supply of medicines shall be within 45 days from the date of the individual supply order.
- 7.3 Supplier shall maintain adequate quantity of quality medicines in stock to meet the demands of VSSC and there shall be no delays in delivering the ordered medicines in time.

8.0 Places of delivery

The medicines are to be supplied at RPP Medical Stores, VSSC, Near SBI Thumba Branch, ISRO PO, Trivandrum and APEP, Alwaye based on Supply Orders issued by CMO, VSSC.

9.0 Liquidated Damages (LD): The delivery date mutually agreed and stipulated in the order is the essence of the Contract. Liquidated Damages @ 0.5% per week of delay or part thereof subject to maximum of 5% or order value including elements of GST, freight & statutory variation is applicable beyond the promised delivery schedule. However, in case of inordinate delay of more than one-fourth in completion period, LD subject to maximum of 10% of the total order value shall be recovered.

10.0 Passing on Special discounts/bonus dose etc. offered by drug companies to VSSC

Occasionally, whenever the company offers special discounts/bonus offers, etc. for the medicines/drugs, to popularize such drugs/ treatments, such benefits shall invariably be passed on to VSSC.

11.0 Payment

- 11.1 VSSC shall make all efforts to ensure prompt payment of your bills as detailed below:
 - i. The invoices/bills should be drawn in the name of Accounts Officer, Centre Accounts, VSSC and forwarded to Chief Medical Officer (CMO), VSSC at the time of supply.
 - ii. On receipt of invoice/bills from supplier CMO shall certify the bills for payment after scrutiny, along with Receipt Voucher in the Supply Order format.
 - iii. Accounts Officer, Centre Accounts, VSSC shall release the payment within 30 working days from date of receipt and acceptance of the items at VSSC.
- 11.2 Supplier's Invoice shall invariably bear the GST Registration No. (GSTIN) & the applicable GST rates with HSN code. In the absence of these, the invoices shall not be processed for payment.
- 11.3 VSSC's GSTIN is 32AAAGV0026J1ZL and our Bankers are State Bank of India, Thumba Branch and IFS Code is SBIN0002279.

12.0 Security Deposit

Upon award of the Rate Contract, Security Deposit (SD) shall be submitted for 3% of the value of the Rate Contract towards satisfactory execution of the Contract. The said Security Deposit shall be submitted either in the form of Insurance surety bond/ Bank Guarantee/ Fixed Deposit receipts or account payee DD from Commercial Banks in India. No exemption is applicable for MSE vendors from submission of Security Deposit. In case PSU/Autonomous bodies/Central Government organisations, Indemnity Bond shall be accepted. Necessary formats will be issued to the successful tenderer along with Purchase order.

- **13.0** Parallel/Adhoc Rate Contract: VSSC shall reserve the right to enter into parallel/adhoc Rate Contract(s) simultaneously, or at any time during the period of the Rate Contract, with one or more agencies.
- **14.0 Fall Clause:** The prices charged for the stores supplied under the Contract by the vendor should in no event exceed the lowest price at which the vendor sells the stores of identical description to any other person during the period of the Contract. If at any time, the prices are reduced, the same shall be notified to the Department and shall stand correspondingly reduced.
- **15.0 Risk Purchase:** The Centre shall also reserve the right to procure the medicines/drugs of similar nature/formulation from the open market in case the pharmaceutical company / authorized dealer fails to make the supply by invoking the risk purchase clause and the difference cost, if any, shall be reimbursed or recovered from the Supplier.
- **16.0 Termination/Short-closure of Rate Contract:** VSSC reserve the right to terminate/short-close the period of Rate Contract during its currency by giving one month's notice.

17.0 Dispute Resolution Mechanism

- (A) **Conciliation**: Notwithstanding anything contained in this Contract, any disputes or differences whatsoever, which are to be settled amicably between the parties, shall be resolved through Conciliation.
- (B) **Mediation**: Any disputes of differences, which are not settled amicably through Conciliation, then either of the parties, may approach for mediation to settle under Mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.

(C) **Arbitration**:

In the event of any dispute/s, difference/s or claim/s arising out of or relating to the interpretation and application of the Contract, such dispute/s or difference/s or claim/s shall be settled amicably by mutual consultations of the good Offices of the respective Parties and recognizing their mutual interests attempt to reach a solution satisfactory to both the parties. If such a resolution is not possible, within 30 days from the date of receipt of written notice of the existence of such dispute/s, then the unresolved dispute/s or difference/s or claim/s shall be referred to the Arbitrator(s) appointed by the Parties by mutual consent in accordance with the rules and procedures of Arbitration and Conciliation (Amendment) Act 2015 as amended from time to time. The arbitration shall be conducted in Bengaluru in the Arbitration and Conciliation Centre – Bengaluru (Domestic and International) as per its rules and regulations. The expenses for the Arbitration shall be shared equally or as may be determined by the Arbitrator. The considered and written decision of the Arbitrator shall be final and binding between the Parties. The applicable language for Arbitration shall be "English" only.

Work under the Contract shall be continued by the SERVICE PROVIDER during the pendency of arbitration proceedings, without prejudice to a final adjustment in accordance with the decision of the Arbitrator unless otherwise directed in writing by

the DEPARTMENT or unless the matter is such that the works cannot be possibly continued until the decision (whether final or interim) of the Arbitrator is obtained.

18.0 Rates (Firm & Fixed)

- 18.1 The rates for products (as listed at **Annexure-2**) of this tender document shall be submitted in the prescribed format. The Price bid shall be submitted as **Annexure E in Part-II Price Bid**.
- 18.2 The rates offered shall be firm and fixed during the entire currency of the Rate Contract and no escalation shall be entertained.
