PRL invites Eol from prospective bidders for Procurement of Microsoft Windows Server OS 2025 or latest licenses on subscription basis for PRL's Server Virtualization IT Infrastructure.

- 1. इस ईओआई का उद्देश्य The objective of this EOI
  - a. सभी बोलीदाताओं की व्यापक भागीदारी सुनिश्चित करना। To have wider participation from the all the bidders.
  - b. बजट प्रावधान के लिए उच्च प्रबंधन का प्रस्ताव करने के लिए बजटीय अनुमान प्राप्त करना। To get budgetary estimate to propose higher management for budget provisioning.

### Note:

- 2. This is Expression of Interest (EOI) not the actual RFP or tender.
- 3. The participation in EOI does not mean qualification in RFP or tender.
- 4. Based on the response received from the bidder in this EOI, PRL will accordingly prepare final RFP.
- 5. The bidder has to supply Windows 2025 server OS or latest Windows server OS version (standard and/or data centre), provide on-site support in installation of OS in virtual infrastructure of PRL as per the details given in technical requirements.
- 6. The bidder should suggest the cost-effective solution for smooth operation in our infrastructure in compliance with Microsoft license policy.
- 7. The bidder must provide budgetary estimate without any violation of license policy as well as to cater the requirement of PRL.
- 8. If there are multiple category of license options for the required product, the bidder must provide separate cost for each option. The price must be quoted to comply as per license policy and also to use on the given PRL setup.
- 9. The objective of this EOI
  - a. To have wider participation from the all the bidders.
  - b. To get budgetary estimate to propose higher management for budget provisioning.
  - c. To get clear understanding of Windows server 2025 licenses policy for Virtual Infrastructure available in PRL. This will help PRL to comply with the license policy.

## **Major Technical Requirements**

# [A] Main Campus (DC site)

PRL has setup virtual infrastructure on VMWare at Main Campus (Data Centre site) and at Thaltej Campus (Disaster Recovery site).

#### **Operational Virtual Infrastructure System Configuration:**

- PRL Has three host base VMware virtualization cluster setup
- Each host machine has 2 sockets with 24 cores per socket.
- Total Core Count: 2 × 24 × 3 = 144 cores per site.
- VMware's server virtualization software is used for virtual setup.

1.	PRL intend to run 4 number of the latest Windows Server 2025 or latest windows server OS in virtual environment.			
2.	Our environment includes VMware- level replication at our DR site. The 4 VMs will run in one site and all these four VMs will be synchronised daily at fixed interval to DR site but it will remain in powered-off state in the disaster recovery site at thaltej campus.			
3.	If one or two physical hosts fail then we should able to v-motion the VMs to the remaining hosts without any additional licences.			

### [B] Thaltej Campus (Disaster Recovery site)

PRL use make this site operational only in case of issue at main campus data centre site. To safeguard the infrastructure and to provide reliable service, PRL takes daily replication of services to this disaster recovery site. So, in case of issue at main campus data centre, PRL can run the service from this disaster recovery site. The setup is completely identical to main campus data centre. However, for reference, it is again given below.

#### **Operational Virtual Infrastructure System Configuration:**

- PRL Has three host base VMware virtualization cluster setup
- Each host machine has 2 sockets with 24 cores per socket.
- Total Core Count: 2 × 24 × 3 = 144 cores per site.
- VMware's server virtualization software is used for virtual setup.

### **Terms and Conditions:**

### 1. Authorized Microsoft Partner

The vendor must be a valid and authorized Microsoft Licensing Partner. Proof of partnership (such as Microsoft Partner ID or certification) must be submitted with the EOI response.

### 2. License Compliance and Mobility

The proposed licensing model must fully comply with Microsoft's licensing terms, including support for virtualization, disaster recovery replication, and VM mobility (e.g. VMware vMotion) without incurring additional license costs.

### 3. Support and Installation Services

The vendor must provide on-site installation support, service and basic configuration of the services, along with guidance for proper license deployment in a virtualized environment.

### 4. Warranty

The vendor must provide license subscription price for three years from the date of installation and activation from PRL. PRL should be given auto/free upgrade also to the supplied license product till the subscription is active.

### 5. Documentation and Delivery

All licenses must be delivered with official documentation, including license keys, activation instructions, and proof of authenticity. Any Software Assurance or warranty coverage must also be documented. The bidder must provide quoted license policy document of Microsoft.

### 6. Onsite Training

The vendor must arrange to provide onsite one or two days training to designated 10 to 15 staff members of PRL on general Windows Server OS management and System administration past without any additional cost to PRL. The trainer has to be a Microsoft certified engineer, documentary proof for the same has to be submitted along with their bid.
