## **2. Registration Procedure**

Interested NGOs/ institutions may fill the details as per the prescribed format enclosed to the Announcement of Opportunity, and shall submit a proposal to CBPO, outlining their profile and proposed plan for engagement in the STEM activities. ISRO shall evaluate the NGOs/ Institutions proposals and shortlist them based on the eligibility criteria. Shortlisted NGOs/ institutions will enter into an MoU with ISRO as registered space tutor.
